Confidential cardholder data is unreadable until it reaches the secure decryption environment. This makes this data considerably less valuable if stolen in a security breach. Merchants using P2PE solutions have fewer PCI Security Council Data Security Standard (PCI DSS) requirements, which greatly simplifies compliance efforts. Additionally, merchants managing their own P2PE solutions for their locations have greater flexibility in implementing and managing the system. Alternatively, merchants have the option to leave this to the solution provider, such as a processor, who is tasked with creating and implementing a solution that protects customer data and reduces risk.
